Inc., the largest full-service restaurant corporation in the world with 2012 revenues of \$7.99 billion, has traditionally and historically kept its doors closed on Thanksgiving;

WHEREAS, since first opening in 2007, there has been a steady and notable reduction of workplace benefits, including but not limited to modifications of employee raises and restructuring of position wages, holiday time, and employee discounts; and

WHEREAS, Darden is for the first time ordering its employees to work on Thanksgiving without any requisite incentive pay; and

WHEREAS, after a long series of workplace benefit reductions and eliminations, the employees of the Capital Grille located in Downtown Pittsburgh have decided to stand up and assert, together, that it is their right to a fair workplace and a Thanksgiving that they may share at home with family.
