Delaney, M.D., 1380 Old Freeport Rd, Pittsburgh, PA 15238, for payment of professional services rendered in Raymond Burke, et al. vs. City of Pittsburgh, Common Pleas Court of Allegheny County, No. GD11-008932, arising from an alleged incident that occurred on June 12, 2009. **Be it resolved by the Council of the City of Pittsburgh as follows:**
