**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1** of Resolution No. 599, effective September 24, 2013, is hereby amended to read as follows:

The Mayor is hereby authorized to issue and the City Controller to countersign warrants in the total sum of \$3,871.83, payable as follows: in the sum of \$3,287.93 in favor of Edgar C.
