## Be It Resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** That the Urban Redevelopment Authority of Pittsburgh is hereby authorized to acquire, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition, all of the City's right, title and interest, if any, in and to publicly-owned properties known as Block 125-L, Lots 288 and 290; Block 125-M, Lots 371, 372, 375, 376, 377, 378, 379, 381, 383, 388, 391; Block 125-S, Lots 18, 19, 19-1, 130,in the 12th Ward of the City of Pittsburgh.

Section 2. That the Urban Redevelopment Authority of Pittsburgh is authorized to incur said necessary and incidental expenses in connection with said acquisition.
