WHEREAS, after joining STANDING FIRM: the Business Case to End Partner Violence in 2010, **Familylinks** has implemented best practice action steps suggested by STANDING FIRM, including Board approved policies and procedures for assisting employees who might be victims of partner violence; and,

WHEREAS, to create a culture of safety in the workplace, **Familylinks** also provides new employee orientation to make new employees aware of resources available to them and in-person training for managers and supervisors so that they will be able to recognize victims and perpetrators, know what to say, and know where to refer; and,
