Resolution amending Resolution No. 300 approved May 6, 2014, providing for the implementation of the Residential Parking Permit Program (RPPP) area "R" in the Bloomfield community (Council Districts #7) to remove from the district to exclude addresses pursuant to Pittsburgh Code Chapter 549.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Within the area bounded by: 40th Street, from Cabinet Way to Wooldslayer Way; Fisk Street, from Penn Avenue to Howley Street; Canoe Way, from Clement Way to a point approximately 80 feet north of Cabinet Way; Cabinet Way, from 40th Street to Main Street; Howley Street, from 40th Street to Main Street; Main Street, from Wooldslayer Way to Liberty Avenue (even number addresses only); Penn Avenue, from 40th Street to 4058 Penn (even number addresses only); Wooldslayer Way, from Fisk Street to Main Street; Clement Way, from Fisk to Main including only 4051, 4053, 4061, and 4069 Liberty Avenue; Mintwood Street, from 39th Street to Fisk Street; Ella Street, from Panama Way to Minerva Street; Orwell Way, from Panama Way to Minerva Street; Taylor Street, from Panama Street to its terminus; Sapphire Way, from Panama Way to Lorigan Street; Pearl Street, from Panama Way to Lorigan Street; Garnet Way, from Panama Way to its terminus; Panama Way, from Ella Street to Pearl Street; Idaline Street, from Ella Street to Pearl Street; and Minerva Street, from Ella Street to Pearl Street.

IS HEREBY AMENDED TO READ:

Within the area bounded by: 40th Street, from Cabinet Way to Woolslayer Way; Fisk Street, from Penn Avenue to Howley Street; ~~Canoe Way, from Clement Way to a point approximately 80 feet north of Cabinet Way;~~ Canoe Way, from Clement Way to Cabinet Way; Cabinet Way, from 40th Street to Main Street; Howley Street, from 40th Street to Main Street; Main Street, from Woolslayer Way to Liberty Avenue (even number addresses only); Penn Avenue, from 40th Street to 4058 Penn (even number addresses only); Woolslayer Way, from Fisk Street to Main Street; Clement Way, from Fisk to Main including only 4051, 4053, 4061, and 4069 Liberty Avenue; Mintwood Street, from 39th Street to Fisk Street; Ella Street, from Panama Way to Minerva Street; Orwell Way, from Panama Way to Minerva Street; Taylor Street, from Panama Street to its terminus; Sapphire Way, from Panama Way to Lorigan Street; Pearl Street, from Panama Way to Lorigan Street; Garnet Way, from Panama Way to its terminus; Panama Way, from Ella Street to Pearl Street; Idaline Street, from Ella Street to Pearl Street; and Minerva Street, from Ella Street to Pearl Street.
