Resolution authorizing the Pittsburgh Parks Conservancy of the City of Pittsburgh in Allegheny County to apply for a Watershed Restoration and Protection (WRPP) grant of \$300,000 from the Commonwealth Financing Authority of the Commonwealth of Pennsylvania.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Pittsburgh Parks Conservancy, in partnership with the City of Pittsburgh Department of Public Works, are authorized to apply for a Watershed Restoration and Protection (WRPP) grant, in the amount of \$300,000, to be used for green infrastructure projects in and adjacent to McKinley Park.

- Area one is bound by Bernd Street, Zelda Way and Beltzhoover Avenue, where GI features can be implemented to capture water flows and divert them away from catch basins into McKinley Park
- Area two involves directing stormwater into McKinley Park from Delmont, Michigan and Eldora Streets
