The Mayor, Director of City Planning and Director of the Human Relations Commission, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement/Agreements, in the form approved by the City Solicitor with the Fair Housing Partnership, for providing comprehensive fair housing training to all relevant members of the City of Pittsburgh's Department of City Planning, ~~and~~ Mayor's Office staff, and City Council's Office Staff.
