Resolution authorizing and directing the issuance of a warrant in favor of Stanley Convergent, a local sub-unit of Stanley, in the amount of Thirty Seven Thousand Eight Hundred Twelve Dollars and One Cent (\$37,812.01), for costs incurred by the Pittsburgh Bureau of Police (PBP), that did not fall within guidelines of an existing contract with Stanley.

### Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of Public Safety are hereby authorized, on behalf of the City of Pittsburgh, to issue, and the City Controller to countersign a warrant in favor of Stanley Convergent, in the amount of Thirty Seven Thousand Eight Hundred Twelve Dollars and One Cent (\$37,812.01) for the cost of equipment and labor completed by a local sub-unit of Stanley for security enhancements to the PBP's Narcotics evidence drug room and Narcotics and vice drug room that did not fall within the guidelines of the contract with Stanley. The invoices totaling Thirty Seven Thousand Eight Hundred Twelve Dollars and One Cent (\$37,812.01) should be chargeable to and payable from the Confiscated Narcotics Proceeds Trust Fund 24016.2300241600.53.53529.2015
