*WHEREAS*, **Domestic Violence Awareness Month**, whose intent was to connect battered women's advocates across the nation who were working to end violence against women and children, evolved from the first Day of Unity observed in October 1981 by the National Coalition of Domestic Violence ; and,

*WHEREAS*, the first **Domestic Violence Awareness Month** was observed in October 1987, the same year the national toll-free hotline was begun and two years before the Legislation was passed by the U.S. Congress marking October as DV Awareness Month; and,

*WHEREAS*, founded in 2009, **STANDING FIRM** is a non-profit organization whose goal is to alert employers to financial, safety and human costs of partner violence in the workplace and offer them tools for taking effective organizational action; and,

*WHEREAS*, STANDING FIRM teaches their member employers how to recognize that partner violence is a business issue that affects productivity and security, how to respond appropriately from a menu of actions steps to address the effects of partner violence and then how to refer to existing community resources for services that the employer does not have the expertise or ability to provide. STANDING FIRM has nearly 300 employee members who participate in their valuable services in the Pittsburgh region; and,
