it is herewith affirmed that the proposed Institutional Master Plan for The Pressley Ridge Schools has properly met the standards as provided in the Pittsburgh Code Section 905.03.D.

**Section 2.** Under the provisions of Sections 905.03.D and 922.12.G of the Pittsburgh Code, approval is hereby granted to The Pressley Ridge Schools for an Institutional Master Plan, on property zoned EMI, Educational/Medical Institution District in accordance with Institutional Master Plan Application No. 21 and accompanying document entitled "Institutional Master Plan" and dated January 15, 2016 as approved by the City of Pittsburgh Planning Commission March 8, 2016, and which are on file in the Office of the Zoning Administrator, Department of City Planning, and which are incorporated herein by reference thereto.
