**WHEREAS**, the City of Pittsburgh has duly enacted Title 11of the Code of Ordinances, which protects and preserves Historic Structures, Districts, Sites, and Objects; and

**WHEREAS**, Lindsay Patross has nominated the Albright United Methodist Church (486 S. Graham Street) for designation as a Historic Structure; and

**WHEREAS**, the Historic Review Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

**WHEREAS**, the Historic Review Commission has voted to recommend that City Council DESIGNATE the Albright United Methodist Church (486 S. Graham Street) as a Historic Structure; and

**WHEREAS**, the City Planning Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the City Planning Commission has voted to recommend that City Council DESIGNATE the

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** Pursuant to the provisions of Title 11 of the Code of Ordinances, the Council of the City of Pittsburgh hereby designates as a Historic Structure the building known as the Albright United Methodist Church, located at 486 S. Graham Street, block and lot number 51-M-155 and 51-M-155-0-2, in the 8<sup>th</sup> Ward, City of Pittsburgh.
