Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to submit an Application to the Pennsylvania Office of the Budget for a Redevelopment Assistance Capital Program grant of up to \$1,000,000 for the Blind & Vision Rehabilitation Services project. (Council District 6)

**WHEREAS**, the City of Pittsburgh (the “City”) and the Urban Redevelopment Authority of Pittsburgh (“URA”) wish to obtain from the Commonwealth of Pennsylvania Office of the Budget (the “Commonwealth”) a grant under the Redevelopment Assistance Capital Program (“RACP”) of up to \$1,000,000 to be used for the Blind & Vision Rehabilitation Services project (the “Project”); and

**WHEREAS**, the Commonwealth requires the City to agree to reimburse it for any expenditure of RACP funds determined by the Commonwealth to be ineligible;

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Urban Redevelopment Authority of Pittsburgh is hereby authorized to file an application with the Commonwealth of Pennsylvania Office of the Budget for a grant under the Redevelopment Assistance Capital Program of up to \$1,000,000 for the Blind & Vision Rehabilitation Services project.

**Section 2.** The City agrees to reimburse the Commonwealth for any expenditure of RACP funds in the amount of \$1,000,000 determined by the Commonwealth to be ineligible.
