Resolution authorizing the Mayor and the Director of the Office of Management and Budget (“OMB”) to enter into an agreement with Deloitte Consulting to perform an operational review of information technology organization, infrastructure and operations, whereby the Commonwealth issued a Consulting Services Invitation to Qualify (ITQ) for the Master IT Services (ITS) through an Invitation for Bids (IFB) and Deloitte Consulting submitted a bid in response to the ITQ. Cost not to exceed \$200,000.00.

WHEREAS, pursuant to the Pennsylvania Intergovernmental Cooperation Law, Act 57 of 1998 and Act 180 of 1972 as amended by Act 148 of 1986 which permits municipalities to participate in or make direct purchases off contracts for services entered into by the Commonwealth of Pennsylvania, the City has a need for Information Technology (IT) Consulting Services (the “Services”) offered by Deloitte Consulting; and

WHEREAS, the Commonwealth issued an Invitation to Qualify (ITQ) for the Master IT Services ITQ through an Invitation for Bids (IFB) and Deloitte Consulting submitted a bid in response to the ITQ; and

WHEREAS, the Commonwealth has the authority to enter into an ITQ Contract for the Services on a multiple award basis according to Section 517 of the Commonwealth Procurement Code, 62 Pa.C.S. §517; and

WHEREAS, the Commonwealth has evaluated Deloitte Consulting’s proposal and determined that the Contractor has met the qualification requirements of the ITQ.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Office of Management and Budget are hereby authorized to enter into an agreement with Deloitte Consulting to perform an operational review of information technology organization, infrastructure and operations, whereby the Commonwealth issued an Consulting Services Invitation to Qualify (ITQ) for the Master IT Services (ITS) through an Invitation for Bids (IFB) and Deloitte Consulting submitted a bid in response to the ITQ

**Section 2.** The costs for the agreement hereof shall be and are hereby limited to the sum of two hundred thousand dollars and zero cents (\$200,000.00), appropriated for the same, chargeable to and payable from the following JDE Code Account Numbers:
