Section 1. The Mayor and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements, or to use existing Agreements, in form approved by the City Solicitor, for compensating Commonwealth of Pennsylvania the local costs associated with federally funded improvements undertaken by PennDOT on City streets, bridges and other City Infrastructure, at a cost not to exceed \$122,066.80, chargeable to and payable from the following account:
