Section 1 of Resolution No. 713, effective December 13, 2016, which presently reads as follows:

"The Mayor and/or the Director of the Department of Finance and/or the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to enter into agreements, in a form approved by the City Solicitor, providing for an up to \$750,000.00 grant from the U.S. Department of Transportation, up to \$490,000.00 in an RCAP grant through the URA, and \$1,604,995.00 from the Riverlife Task Force, for the construction of the "Mon Wharf Switchback Ramp".
