**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Department of Parks and Recreation are authorized to enter into a License Agreement with the **Pittsburgh Parking Authority for the parking lot at the intersection of Broadway and Beechview Avenue, Pittsburgh, PA 15216** ~~Catholic Diocese of Pittsburgh, St. Catherine of Sienna Parish parking lot located at Broadway Avenue and Belasco Street~~ for the 2017 Farmers' Market for \$1 and no additional rental charge to the City. The Agreement shall be in form and substance approved by the City Solicitor.
