## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Office of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into a professional service Agreement or Agreements with Zucker Systems to optimize the City's development review processes.

Funds shall be paid from the following account:
