Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of City Planning, on behalf of the City of Pittsburgh, are hereby authorized and directed to enter into a Cooperation Agreement or Agreements with the Urban Redevelopment Authority of Pittsburgh, in a form approved by the City Solicitor, under which the Urban Redevelopment Authority of Pittsburgh will undertake the following programs and activities in connection with the 2017-2018 Community Development Block Grant Program at a cost not to exceed Four Million Six Hundred Four Thousand Four Hundred (\$4,604,400.00) Dollars, chargeable to and payable from the 2017 Community Development Block Grant Trust Fund as follows:
