## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of City Planning are hereby authorized to enter into contract and hire consultant, Farmers' Market Coalition to perform a study and develop a plan. The study and plan should be executed for a sum not to exceed Forty-Six Thousand Dollars and Zero Cents (\$46,000.00). This cost includes evaluation, research, data collection, analysis and recommendations for our regional farmers' market system.
