They have been appointed to federal and state judgeships, elected to numerous local, state, and federal government positions, and serve as leaders of hundreds of important legal, corporate, industry, and non-profit organizations; and,

collaborate, build relationships, and influence change with an exclusive group of likeminded professionals; and,
