Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Resolution No. 404 of 2015, entitled, "Resolution authorizing the approval of an inter-municipal transfer of restaurant liquor license, License No. R-12467, LID-60311 from Damon's International, Inc., 4070-4072 William Penn Hwy., Monroeville, PA 15146-2685 to the Applicant, Mixtape, LLC. 4907 Penn Avenue, Pittsburgh, PA 15224 for the premises located at 4907 Penn Avenue, Pittsburgh, PA 15224, restaurant known as "Mixtape" pursuant to amended Pennsylvania Liquor Code, §4-461," is hereby amended by approving rescindment of the Conditional Licensing Agreement between Mixtape, LLC and the Pennsylvania Liquor Control Board as per paragraph 5(g) thereof. This Conditional Licensing Agreement previously had incorporated the terms and conditions of the Memorandum of Understanding between Mixtape, LLC and the Bloomfield-Garfield Corporation, as amended pursuant to Resolution Number 651 of 2016, and Section 6, as approved in Resolution Number 404 of 2015. This approval of rescinding the Conditional Licensing Agreement between Mixtape, LLC and the Pennsylvania Liquor Control Board is not intended to modify the terms of any Memorandum of Understanding or Agreement between Mixtape, LLC and the Bloomfield-Garfield Corporation.

Section 2. All other language contained in Resolution 404 of 2015 remains unchanged.
