## The Council of the City of Pittsburgh hereby enacts as follows:

**Section 1.** The Pittsburgh Code, Title Nine, Zoning, Article I, Section 901.02 Official Zoning Code and District Map is hereby amended as follows:

901.02 - Official Zoning Code and District Map
