She also co-chaired 4 Annual Meetings, co-chaired Project Prom for its initial 2 year launch, co-chaired a Designer Days Patron Party, has been on the Retail Assessment Committee charged with assessing 3 retail stores, was on the Task Force that created the Center for Women as well as serving on the Center's Partners Council and is the current co-chair of
