### Be it resolved by the Council of the City of Pittsburgh as follows:

#### Section 1.

Resolution No. 541, effective August 6, 2018, which presently reads as follows:

The Mayor and the Director of the Office of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements, in a form approved by the City Solicitor, with the following various community organizations for operational/administrative expenses; maintenance, and/or rehabilitation of neighborhood facilities; and for administrative/operational costs, maintenance, purchase of equipment, and/or rehabilitation of neighborhood facilities of various departmental programs/projects for the

benefit of residents of the City of Pittsburgh, at a cost not to exceed \$365,000.00, chargeable to and payable from the 2018 Community Development Block Grant Program and the listed code accounts in the Mayor's Office.
