Resolution authorizing the Mayor and the Director of the Department of Innovation and Performance to enter into an Agreement or Agreements with SmartWorks Partners, Inc, **Cohen Law Group, and CTC Technology & Energy** for the provision of professional services relating to telecommunications strategy, with a 65/35 revenue sharing split. (*Briefing held 10/23/18*)

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Department of Innovation & Performance, on behalf of the City of Pittsburgh, are hereby authorized to enter into a Contract or Contracts, Agreement or Agreements, with SmartWorks Partners, Inc., **Cohen Law Group, and CTC Technology & Energy** for the provision of professional services relating to telecommunications strategy development and negotiations of the City's telecommunications agreements. The term of the agreement shall be for six (6) years.

**Section 2.** SmartWorks Partners, Inc., **Cohen Law Group, and CTC Technology & Energy** shall provide services relating to broadband planning, policy review, implementation, and ongoing program management. SmartWorks Partners, Inc., **Cohen Law Group, and CTC Technology & Energy** shall receive a contingency fee of 35% of all new revenue collected from mutually agreed upon City-owned telecommunications and smart city assets. Revenue, less this fee, shall be deposited into the appropriate Innovation and Performance 103000 revenue account, including but not limited to:

Cable Bureau Revenue: 11101.103000.43.43101

Leasing and management of City-Owned assets, MBRO revenue:11101.103000.43.43905

Telecommunications Licensing tax: 11101.103000.43.41658

Distributed Antennae Permit revenue: 11101.103000.43.43105

**Section 3.** Said Agreement(s) shall be in a form approved by the City Solicitor.
