Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to acquire all the City's Right, Title and Interest, if any, in and to the Publicly-Owned Properties in the 18<sup>th</sup> Ward of the City of Pittsburgh designated in the Deed Registry Office of Allegheny County as Block 15-R, Lots 231 and 268, Block 15-S, Lots 14, 26, 170, 175, 189, 192, 196, 197, 198 and 199, and Block 34-D, Lot 14 (Council District No. 3 - 847 Gearing Avenue, 704 Delmont Avenue, 235 and 315 Michigan Street, 809, 811, 817, 827, 835, 903, 911, and 919 Eldora Place).

**Whereas**, the Urban Redevelopment Authority of Pittsburgh desires to acquire all the City's right, title and interest, if any, in and to publicly-owned properties known as Block 15-R, Lots 231 and 268, Block 15-S, Lots 14, 26, 170, 175, 189, 192, 196, 197, 198 and 199, and Block 34-D, Lot 14 in the 18<sup>th</sup> Ward of the City of Pittsburgh, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition.

**Whereas**, the Council of the City of Pittsburgh desires to give approval to the acquisition by Urban Redevelopment Authority of Pittsburgh.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** That the Urban Redevelopment Authority of Pittsburgh is hereby authorized to acquire, for the

sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition, all of the City's right, title and interest, if any, in and to publicly-owned properties known as Block 15-R, Lots 231 and 268, Block 15-S, Lots 14, 26, 170, 175, 189, 192, 196, 197, 198 and 199, and Block 34-D, Lot 14 in the 18<sup>th</sup> Ward of the City of Pittsburgh.

**Section 2.** That the Urban Redevelopment Authority of Pittsburgh is authorized to incur said necessary and incidental expenses in connection with said acquisition.
