Section 2. The funds allocated to Observatory Hill-Surveillance Cameras shall be utilized for the procurement, installation, and operation of surveillance cameras in the Observatory Hill neighborhood.

Section 3. The funds allocated to Summer Hill Citizens Council shall be utilized for signs and equipment.

Section 4. The funds allocated to Brighton Heights Citizens Federation-community group office shall be utilized for office rent and office supplies

Section 5. The funds allocated to Brighton Heights Citizens Federation-Surveillance Cameras shall be utilized for the procurement, installation, and operation of surveillance cameras in the Brighton Heights neighborhood.

Section 6. The funds allocated to the Poise Foundation shall be utilized in support of the Juneteenth Festival, including but not limited to reimbursing the Stop the Violence Pittsburgh organization for any expenses incurred producing the festival.
