WHEREAS, a Pittsburgh native, Dr. John M. Wilds received a Bachelor of Arts degree in Social Science and Psychology, a Master's degree in Counseling Psychology, and a Doctorate in Counseling, all from the University of Pittsburgh; and,

**WHEREAS**, prior to joining the faculty of his alma mater in 1985, Dr. Wilds was Vice President of Human Resources for Warner Cable Corporation of Pittsburgh and served in managerial roles in human resources, employee development, labor relations, and equal employment opportunity at Jones and Laughlin Steel Company; and,

WHEREAS, Dr. Wilds' professional roles at the University of Pittsburgh have included Director of Human Resources, Director of Governmental Relations, Assistant Vice Chancellor for Community and Governmental Relations, and Assistant Vice Chancellor for Community Relations, which is his current position; and,

WHEREAS, in his current role, Dr. Wilds fostered relationships with local, state, and federal government representatives, neighborhood groups, non-profit organizations, and the business community and designed and executed the "Be a Good Neighbor Program," which helps to improve town-gown relations in surrounding Oakland communities. Among countless other accomplishments, Dr. Wilds participated in the University of Pittsburgh's Community Outreach Partnership Center, which promoted civic engagement, community service, and partnerships and linked University resources to the region; and,
