Resolution authorizing the Mayor and the Director of the Department of Public Safety to enter, on behalf of the City of Pittsburgh, into an Agreement or Agreements with the National Association of State Boating Law Administrators (NASBLA) for training and certification services regarding Public Safety boat operations at a sum not to exceed Three Hundred Sixty Thousand Dollars (\$360,000.00) and providing for the payment of the costs thereof.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Safety are hereby authorized to enter, on behalf of the City of Pittsburgh, into an Agreement or Agreements with National Association of State Boating Law Administrators (NASBLA) for the provision of training and certification services regarding Public Safety boat operations at a cost not to exceed THREE HUNDRED SIXTY THOUSAND DOLLARS and NO CENTS (\$360,000.00) and providing for the payment of the costs thereof, chargeable to and payable from the following account codes in their respective budget years, **subject to annual appropriation by City Council**:
