WHEREAS, pursuant to Resolution No. 641 effective September 28, 2018, the City of Pittsburgh and the Federal General Services Administration (GSA) entered into a Non-Exclusive License Agreement, expiring December 31, 2018, for access to the Veterans Affairs Highland Drive Campus at 7180 Highland Drive, Pittsburgh, PA 15206; and

WHEREAS, pursuant to Resolution No. 32 effective January 10, 2019, the City of Pittsburgh and the GSA extended the Non-Exclusive License Agreement, through a period expiring April 30th, 2019,; and

WHEREAS, the GSA and the City of Pittsburgh wish to execute a second renewal of the expiring agreement; and

Be it resolved by the Council of the City of Pittsburgh as follows:
