Additionally, the City will provide matching funds in the form of in-kind services valued at \$10,000.00 offered by the City of Pittsburgh.

Resolution authorizing the Mayor and Director of the Department of Public Works to execute relevant Agreements and Contracts to receive grant funding from the Pirates Charities' Fields for Kids Program to update Devlin Field located in the 16th Ward of the City of Pittsburgh, and further providing for an Agreement, Contracts and expenditures not to exceed TEN THOUSAND (\$10,000.00) dollars for this stated purpose. Additionally, the City will provide matching funds not to exceed TEN THOUSAND (\$10,000.00) dollars in order to receive said grant funds to be used for the same purpose. Additionally, the City will provide matching funds in the form of in-kind services valued at \$10,000.00 offered by the City of Pittsburgh.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Works of the City of Pittsburgh, are authorized to execute relevant Agreement or Contracts and expenditures with the Pirates Charities in order to receive a grant award in the amount of TEN THOUSAND (\$10,000.00) dollars for the purpose of renovating Devlin Field located in the 16th Ward of the City of Pittsburgh. Additionally, the City will provide matching funds in the form of in-kind services valued at \$10,000.00 offered by the City of Pittsburgh. Monies from the grant agreement shall be deposited into the Grants Trust Fund account 4029400271.48311.00.

Section 2. The Mayor and the Director of Public Works of the City of Pittsburgh, are further authorized to

enter into an Agreement or Agreements, or the use of existing Agreements, a Contract or Contracts, or the use of existing Contracts, and expenditures at a cost not to exceed TEN THOUSAND (\$10,000.00) dollars, additionally, the City will provide matching funds in the form of in-kind services valued at \$10,000.00 offered by the City of Pittsburgh for the purpose of renovating Devlin Field located in the 16th Ward of the City of Pittsburgh and under the terms of the agreement between the City of Pittsburgh and Pirates Charities, chargeable to and payable from the Grants Trust Fund account 4029400271.50000.00.
