The grant proposal includes an ask of \$93,500.00 \$139,674.35 with a local match of \$16,500.00 \$24,651.93 to be funded from the 2020 City of Pittsburgh Capital Budget. In the event the grant is awarded, this resolution provides for an agreement and expenditures not to exceed ONE HUNDRED TEN THOUSAND (\$110,000.00) dollars ONE HUNDRED SIXTY FOUR THOUSAND THREE HUNDRED TWENTY SIX DOLLARS AND TWENTY EIGHT CENTS (\$164,326.28) for this stated purpose.

Section 1. The Mayor, the Director of the Department of Public Works, and/or the Director of the

Department of Mobility and Infrastructure, are authorized to apply for grant funding from the Pennsylvania Department of Community and Economic Development Greenways, Trails and Recreation Program (GTRP) to provide funding for the planning of the renovation of the Pedestrian Tunnel located in Highland Park. The total project cost is \$110,000.00. The grant proposal includes an ask of ~~\$93,500.00~~ **\$139,674.35** with a local match of ~~\$16,500.00~~ **\$24,651.93** to be funded from the 2020 City of Pittsburgh Capital Budget (JDE 4550000120, FUND 40020). In the event the grant is awarded, this resolution provides for an agreement and expenditures not to exceed ~~ONE HUNDRED TEN THOUSAND (\$110,000.00) dollars~~ **ONE HUNDRED SIXTY FOUR THOUSAND THREE HUNDRED TWENTY SIX DOLLARS AND TWENTY EIGHT CENTS (\$164,326.28)** dollars for this stated purpose.
