Said agreement or agreements or expenditures are at a cost not to exceed \$21,798,636.00.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, are hereby authorized to enter into Agreements for the purposes of receiving grant funding for implementation of the Advanced Transportation and Congestion Management Technologies Development (ATCMTD) project. Grant funding totals are \$10,899,318.00.

**Section 2.** The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the

City of Pittsburgh, are hereby authorized to advertise for proposals and to award and to enter into a Contract or Contracts, or to use existing Contracts, an Agreement or Agreements, or to use existing Agreements with a Consultant or Consultants, for implementation of the Advanced Transportation and Congestion Management Technologies Development (ATCMTD) project; The project is at a cost not to exceed \$21,798,636.00, with the City responsible for a 50% match of the federal high portion.

The total funding for this project will come from \$10,899,318.00 from FHWA & 10,899,318.00 from city funds. The phasing for the City dollar amounts is subject to the schedule seen here.
