Resolution amending Resolution number 515 of 2019, entitled "Resolution authorizing the Mayor and the Director of Public Safety to enter on behalf of the City of Pittsburgh into a two-year Professional Services Agreement or Agreements with **one** <u>an</u> option to renew <u>for one year</u> with The Center that CARES for the purpose of implementation of the Pittsburgh Group Violence Intervention Street Outreach Program" so as to increase the funding by <u>\$33,333.65 for 2019</u>, \$100,000 per year <u>for 2020 and 2021, and \$66,666.33 for year 2022</u>.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Section 1 of Resolution number 515 of 2019 is hereby amended as follows:

Section 1. The Mayor and the Director of Public Safety are hereby authorized and directed to enter on behalf of the City of Pittsburgh into a two-year Professional Services Agreement or Agreements with <u>a</u> one <u>year</u> option to renew with The Center that CARES for the purpose of enhancing the continuum of services provided through the Pittsburgh Group Violence Intervention Street Outreach Program at a cost not to exceed [Six] <u>Nine</u> Hundred Thirty Seven Thousand Five Hundred Dollars and No Cents (\$[6]<u>9</u>37,500.00), chargeable to and payable from the following:
