Be it resolved by the Council of the City of Pittsburgh as follows:

Sections. Resolution No. 341 of 2016, is hereby amended to further authorize the Mayor, the Director of the Department of Public Works and the Director of the Department of Innovation and Performance to enter into an amended agreement or agreements with Cartegraph Systems, Inc., in order to continue licensing application software and for the purchase of associated subscription, maintenance, cloud hosting and professional services. Terms and conditions included in the original agreement or agreements procured through CoStars may be agreed upon by the parties to extend to the amendment(s). The cost of amending and extending the agreements for years 2019, 2020 and 2021 shall not exceed Five Hundred Fifty-Nine Thousand
