Resolution approving Execution of a Deed by and between the Urban Redevelopment Authority of Pittsburgh and City of Pittsburgh, for the sale of Block 83-P, Lot 249, in the 11th Ward of the City of Pittsburgh Council District No. 9 (Broad Street Plaza and Roadway Improvements).

Whereas, the Urban Redevelopment Authority of Pittsburgh has requested authorization to execute a Deed by and between the Urban Redevelopment Authority of Pittsburgh and the City of Pittsburgh in connection with the sale of Block 83-P, Lot 249, in the 11<sup>th</sup> Ward of the City of Pittsburgh, for the sum of \$1.00, and

Whereas, the City of Pittsburgh has requested authorization to accept the aforementioned Deed; and

Whereas, the Council of the City of Pittsburgh believes that the proposed conveyance is in the best interest of the City of Pittsburgh and desires to give its approval in accordance with the provisions of the Urban Redevelopment Law.

**Now, Therefore, be it resolved by the Council of The City of Pittsburgh as follows:**

**Section 1.** That execution of a Deed by and between the Urban Redevelopment Authority of Pittsburgh and the City of Pittsburgh in connection with the sale of Block 83-P, Lot 249, for \$1.00, said property being in the 11th Ward of the City of Pittsburgh, be and the same is hereby approved,
