Resolution authorizing the Mayor and the Director of the Department of City Planning to enter into contract and hire consultant, LaQuatra Bonci Associates, to develop a master plan for Fort Pitt Park. ## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of City Planning are hereby authorized to enter into contract and hire consultant, LaQuatra Bonci Associates, to develop a master plan for Fort Pitt Park. The park master plan should be executed for a sum not to Forty Five Thousand Dollars and Zero Cents (\$45,000). This cost includes community outreach, inventory/analysis, plan alternatives, and final master plan.

**Section 2.** Said Agreement or Agreements shall be approved by the City Solicitor as to form.

**Section 3.** Funding used for the Agreement or Agreements with LaQuatra Bonci Associates in furtherance of the Fort Pitt Park Plan process will be chargeable to and payable from the following accounts:
