The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, are herby authorized to enter into a Reimbursement Agreement with the Commonwealth of Pennsylvania, Department of Transportation, for reimbursement of the federal governments' share of costs to the City for the Washington Boulevard Trail project.
