Section 1.

Section 1 of Resolution No. 510, effective August 1st 2019 which presently reads as follows:

The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, **having advertised and received proposals** are hereby authorized [to advertise for proposals and to award and] to enter into a Contract or Contracts **with Kittelson & Associates, Inc.**, [or to use existing Contracts, an Agreement or Agreements, or to use existing Agreements, providing for the planning, design, repairs, maintenance, improvements, emergencies, operations, and / or the purchase of materials, equipment, and supplies] in connection with the production of the Oakland Transportation Study and associated projects.
