## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of Human Resources and Civil Service, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements with Flexable, LLC for professional on-site child care services for a sum not to exceed One Hundred Thirty-One Six Hundred Twenty-Five Dollars (\$131,625.00) over three years, subject to annual appropriation by City Council in future years.
