Resolution authorizing the Mayor and Director of the Department of Public Safety to execute relevant agreements to receive grant funding from the Hillman Family Foundations to support the City’s partnership with Operation Better Block to support the ongoing efforts of the Pittsburgh Bureau of Police and its Group Violence Intervention program and further providing for an agreement and expenditures not to exceed ONE HUNDRED THOUSAND (\$100,000.00) dollars for this stated purpose.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of Public Safety of the City of Pittsburgh are authorized to execute relevant agreements with the Hillman Family Foundations in order to receive a grant award in the amount of ONE HUNDRED THOUSAND (\$100,000.00) dollars for the purpose of supporting the City’s partnership with Operation Better Block to support the ongoing efforts of the Pittsburgh Bureau of Police and its Group Violence Intervention program. Monies from the grant agreement shall be deposited into the Grants Trust Fund account 2329400316.48311.00.

Section 2. The Mayor and the Director of the Department of Public Safety of the City of Pittsburgh are further authorized to enter into agreements, or contracts, or utilize existing agreements or contracts and not to exceed ONE HUNDRED THOUSAND (\$100,000.00) dollars for the purposes of supporting the City’s partnership with Operation Better Block to support the ongoing efforts of the Pittsburgh Bureau of Police and

its Group Violence Intervention program under the terms of the agreement between the City of Pittsburgh and the Hillman Family Foundations chargeable to and payable from the Grants Trust Fund account 2329400316.50000.00.
