Resolution authorizing the Mayor and the Director of the Department of Finance to grant a temporary construction easement to 2013 PA Brushton, LLC to perform land stabilizing work.

**WHEREAS**, 2013 PA Brushton, LLC must perform land stabilizing work, slope regrading, and landscaping (the "Project Work") in Ward 12 of the City; and

WHEREAS, 2013 PA Brushton, LLC desires a temporary construction easement on City property located at lot and block number 173-P-185 (the "Property") for the purpose performing said land stabilizing work; and

**WHEREAS**, the City is willing to grant to 2013 PA Brushton, LLC a non-exclusive temporary right and privilege to enter upon the Property for the purpose of necessary land stabilizing work, slope regrading, and landscaping.

**WHEREAS**, the parties now wish to execute a Temporary Construction Easement to document party responsibilities associated with the land stabilizing work.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of Finance, on behalf of the City of Pittsburgh, are hereby authorized to execute a Temporary Construction Easement Agreement granting a temporary

construction easement to 2013 PA Brushton, LLC to access lot and block number 173-P-185. Said Temporary Construction Easement Agreement shall be in the form approved by the City Solicitor and shall contain such terms and conditions as the Solicitor may require.
