Resolution authorizing the Director of the Department of Finance, on behalf of the City of Pittsburgh to enter into temporary construction easements, in lieu of eminent domain, with the owners of certain properties in the 24th Ward of the City of Pittsburgh, adjacent to Cowley Park, for landslide remediation work related to public park purposes.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Director of the Department of Finance, on behalf of the City of Pittsburgh, is authorized, in lieu of eminent domain, to enter into a temporary construction easement over 1261 Voskamp Street, with the current owner Margie L. and Rock J. Pastin or future owners of the property designated as Block 24-G, Lot No. 51 (24-G-51), in the Deed Registry Office of Allegheny County; for the purposes of conducting certain landslide remediation work related to public park purposes.

Section 2. The Director of the Department of Finance, on behalf of the City of Pittsburgh, is authorized, in lieu of eminent domain, to enter into a temporary construction easement over 1267 Voskamp Street, with the current owners Regis A. & Dolores Stumpf Hartman and Eileen M. Hartman or future owners of the property designated as Block 24-G, Lot No. 54 (24-G-54), in the Deed Registry Office of Allegheny County; for the purposes of conducting certain landslide remediation work related to public park purposes.

Section 3. The Director of the Department of Finance, on behalf of the City of Pittsburgh, is authorized, in lieu of eminent domain, to enter in a temporary construction easement over 1273 Voskamp Street, with the

current owner Suraya Akter or future owners of the property designated as Block 24-G, Lot No. 50 (24-G-50), in the Deed Registry Office of Allegheny County; for the purposed of conducting certain landslide remediation work related to the public park purposes.

Section 4. The Director of the Department of Finance, on behalf of the City of Pittsburgh, is authorized, in lieu of eminent domain, to enter into a temporary construction easement over 1275 Voskamp Street, with the current owner Josephine A. Marinack or future owners of the property designated as Block 24-G, Lot 49 (24-G-49), in the Deed Registry Office of Allegheny County, for the purposes of conducting certain landslide remediation work related to public park purposes.
