Resolution authorizing the Mayor and the City Solicitor, on behalf of the City of Pittsburgh, to enter into a professional services agreement with Cohen Law Group to address a matter of pending telecommunications and cable regulatory litigation at an amount not to exceed twenty-nine thousand dollars (\$29,000).

WHEREAS, the City wishes to participate in appeals of certain orders of the Federal Communications Commission that could adversely impact the City's telecommunications and cable operations and regulation; and

WHEREAS, this appeal represents a matter of pending litigation and Cohen Law Group is qualified to complete the specialized work necessary for the appeal; and

WHEREAS, the City wishes to enter into an agreement with Cohen Law Group to commission the City's appeals to this timely matter of federal telecommunications and cable regulation litigation.

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the City Solicitor, on behalf of the City of Pittsburgh, are authorized to enter into a professional services agreement with Cohen Law Group to address a matter of pending telecommunications and cable regulatory litigation at an amount not to exceed twenty-nine thousand dollars (\$29,000) appropriated from the following code account: 11101.108000.53.53517.2020.
