**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1:** Section 1(A) of Resolution 744 of 1996 shall be amended as follows:

"The City Controller is hereby authorized and directed to create a special trust fund, to be designated as the "Shade Tree Trust Fund", into which trust fund there shall be deposited ~~[any and all]~~ cash from the proceeds of outdoor advertising on bus shelters, contributions from private citizens, companies, foundations, governmental agencies, and any other source, ~~as directed by the Director of the Office of Management and~~

Budget.”
