Resolution authorizing the Urban Redevelopment Authority of Pittsburgh to acquire all the City's Right, Title and Interest, if any, in and to the following Publicly-Owned properties in the 10th Ward of the City of Pittsburgh designated in the Deed Registry Office of Allegheny County as Block 50-G, Lots 60, 62, 63, 65, 66, 68, 69, and 70, located on the north side of Rosetta Street west of North Pacific, and Block 50-K, Lots 172 and 173, located on the south side of Broad Street between North Millvale Avenue and North Winebiddle Street (Council District No. 9).

WHEREAS, the Urban Redevelopment Authority of Pittsburgh desires to acquire all the City's right, title and interest, if any, in and to the above-listed publicly-owned properties in the 10th Ward of the City of Pittsburgh, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition.

WHEREAS, the Council of the City of Pittsburgh desires to give approval to the acquisition by Urban Redevelopment Authority of Pittsburgh.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. That the Urban Redevelopment Authority of Pittsburgh is hereby authorized to acquire, for the sum of \$1.00 plus all necessary and incidental expenses in connection with such acquisition, all the City's right,

title and interest, if any, in and to publicly-owned properties known as Block 50-G, Lots 60, 62, 63, 65, 66, 68, 69, and 70, and Block 50-K, Lots 172 and 173 in the 10th Ward of the City of Pittsburgh.

Section 2. That the Urban Redevelopment Authority of Pittsburgh is authorized to incur said necessary and incidental expenses in connection with said acquisition.
