Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Chief Equity Officer are hereby authorized to enter into a Professional Services Agreement(s) and/or Contract(s) between the City of Pittsburgh and the Government Alliance on Race & Equity (GARE) in order to receive training and develop a racial equity toolkit and to extend the contract for an additional year and add technical assistance for building and implementing a Racial Equity Tooling and developing an equity lens for each Department's budgeting process at a cost not to exceed SIXTY ONE THOUSAND TWO HUNDRED THIRTY FIVE (\$61,235), subject to appropriation.
