## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1**. The Mayor and the Director of the Department of Parks and Recreations of the City of Pittsburgh are authorized to execute relevant agreements with the Digital Harbor Foundation in order to receive a National Science Foundation grant award in the amount of Three Hundred, Forty Five Thousand, One Hundred Eighty Two Dollars and Zero Cents (\$345,182.00) for the purpose of improving technology and technology based education at two City of Pittsburgh Recreation Centers. Monies from the grant agreement shall be deposited into the Grants Trust Fund account: 5029400335.45703.00.
