## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The Mayor and the Director of the Department of Public Works are authorized to receive a grant from the Allegheny County Sanitary Authority in the amount of THREE HUNDRED FIFTY TWO THOUSAND FORTY SEVEN DOLLARS AND NINETY TWO CENTS (\$352,047.92) Wightman Park Green Stormwater Infrastructure - Phase II. Monies from the grant shall be deposited into the Grants Trust Fund account 4029400343. 45100.00.

**Section 2.** The Mayor and the Director of the Department of Public Works are further authorized to enter into an agreement or agreement or the use of existing agreements, a contract or contracts, or the use of existing contracts, at a cost not to exceed of THREE HUNDRED FIFTY TWO THOUSAND FORTY SEVEN DOLLARS AND NINETY TWO CENTS (\$352,047.92) for Wightman Park Green Stormwater Infrastructure - Phase II chargeable to and payable from the Grants Trust Fund Account 4029400343.50000.00.
